C20/218 Apologies for Absence

It was noted Cllr Bowden had an issue connecting to the meeting.

C20/219 Declarations of Members' Interests and Dispensation Applications

None.

C20/220 Community Police

A report was received by the Police.

RESOLVED: To contact the police thanking them for the graphs analysing figures and to ask for clarification on the new reporting method.

C20/221 Public Participation

No member of the public wished to speak.

C20/222 Updates from County and Borough Councillors on matters of concern to the Town Council

HPBC Cllr Lomax sent a written report which is attached to the minutes.

DCC Cllr Ruth George reported that the schools in Derbyshire were operating at roughly half capacity with some doing virtual work with others attending the school. She commented that DCC have been delivering the food parcels to families that are eligible for free school meals and provided thanks to Whaley Bridge Covid Mutual Aid Group for providing assistance delivering the parcels. She continued to state that DCC are considering providing food vouchers rather than the food parcels that they are currently providing which she has been pressing for as they are more convenient for families. She commented that Nurseries across Derbyshire are open and are doing their best although members of staff are worried. As many nurseries receive Government funding they are currently unable to furlough staff which is a worry as not all staff are needed due to the lower numbers. She reported that the Government are currently looking into making this guidance more flexible allowing the Government to further support nurseries.

She continued to state that she had been dealing with a number of flooding issues in the division with numerous blocked drains and gullies reported. She stated she had been addressing a flooding issue on Coachmans Lane in Furness Vale however it is an unadopted road which is causing an issue. She stated that there

had been flooding down the road which has caused gouging in the road, DCC have been out to remove debris from the drains on the road. She stated that there have also been flooding issues on Dolly lane and that DCC are considering placing reflective posts on the edge of the road to help drivers avoid the ditch. She continued to state there have been flooding issues on Eccles Road because a drain or gulley has collapsed on the road. She stated residents on Wharf Road were concerned about the height of the river and that she had spoken to the Environment Agency to see if the water levels in the river can be lowered.

She continued to state that she was scheduled to meet representatives from HPBC regarding the Wharf Road park entrance to make it a better route into the park. She stated that cycle racks had been placed outside the Cock pub and in the Town Centre and that they were looking to place some more in Tom Brad's Croft car park once it has been resurfaced. She stated she had been working with local groups to establish a cycle route along the Peak Forest Tramway asking for funding from the DCC active travel fund.

Finally she stated that fibre broadband installation had been delayed at Tunstead Milton and Fernilee and that she had received assurances from BT Openreach this would be completed by the end of January.
