A report was received by the Police.

C20/242 **Public Participation** 

> A member of the public wished to speak regarding the grit bin on New Horwich Road. He asked for an update to when the grit bin on New Horwich Road was going to be filled and he was informed that it would be tomorrow. He continued to state that he is one of the DCC flood wardens and that there is an issue with water running onto the road then freezing make the road dangerous. Finally he stated that the website was not very accessible and that it was difficult to find the Council's contact details. He was informed that the Council are in the process of getting a new website to address these issues.

#### C20/243 Updates from County and Borough Councillors on matters of concern to the Town Council

HPBC Cllr Lomax sent a written report which is attached to the minutes.

DCC Cllr Ruth George reported that the issues with New Horwich road has been referred to DCC but DCC have had a lot of reports of flooding and at the moment the flood team were not looking at it but a highways officer is coming to look at the road. She continued stating that she has made a referral to DCC about water coming down Canal Street into the Transhipment warehouse. She stated that she hoped the blocked drainage gullies issue on Eccles Road will be done by the 26th of February. She continued to state there will be a closure of Start lane for a replacement of a gas main starting on Monday, she has received lots of concern from residents that the road will have to be fully closed for a time leaving no suitable access. The contractors have spoken to residents and have assured them thy will attempt to keep the road passable as much as possible. She stated she has been notified of issues about lorries on Linglongs Road coming into the Barratts site unloading on the road rather than in the designated area. She has spoken to the clerk of works to assess the situation and make sure that they can actually drop their load in the designated area.

She continued to state that the Bridge Bakehouse issue was raised to HPBC who sent round COVID-19 support officers. There was an agreement that there would be extra staff to make sure the pavement wasn't being blocked at busier times.

She stated she had a meeting regarding the care homes stating White Stones had been proposed for a COVID-19 recovery unit however the home will be used for a recovery unit for people coming out of hospital instead. She has been working with the Buxton Town Team, Acclimatise Whaley and the Chapel Walkers group about the high peak tram way which would link all of the major areas in the High Peak. She stated DCC are going to make a bid to create the cycle route.

Finally she stated BT Openreach have connected the fibre cabinets at Tunstead Milton and Fernilee.
