# C21/228 Updates from County and Borough Councillors on matters of concern to the Town Council

DCC Cllr Ruth George comments the main issue at the moment is flooding which happened yesterday. She commented that the flood wardens did a great job on bottom of Macclesfield Road and the Road to Tunstead Milton. There were more problems on Yeardsley Lane where they put the large drain in, even this new drain couldn't cope with the amount of water. She commented DCC are investigating a possible blockage further up the lane.

The road opposite the solider dick track had a blocked drain which was cleared but is still a problem she has asked DCC for this to be resurfaced as it is a gravely surface which is deteriorating. She continued to state there is still an issue on George Street despite the culvert being dug out. There is a track above George street which is not registered and this seems to be the issue. DCC has informed her there needs to be some form of public or private ownership which needs to come forward to take control of this road. She commented to let her know if there is any other persistent flooding issues causing problems as a DCC flood engineer coming to look at the Shallcross incline drainage issue and will look at other issues as well while he is in the area.

She continued to state that she has had long correspondence with highways safety about the Bridgemont junction stating the no turning right sign is not visible but DCC are refusing to put another sign up at the moment.

She has taken photos and videos of the junction to try and convince DCC to get another traffic sign, however so far she has been unsuccessful.

She commented DCC have put school crossing patrol signs on Market Street the one for left turning onto Reservoir Road is slightly obscured and the one on the other side of the road is basically invisible as it cannot be seen by right turning traffic, she commented she had notified DCC regarding the issue.

DCC have informed her that the CRT stopped looking at lowering the road under the railway bridge at Reservoir Road.

She commented there are still arguments about the footpath by the Cock pub the are CRT saying no one has checked their documents to say whether they own it or not due to home working arrangements.

Finally she commented that she understands that HPBC are looking at the Tesco second bridge issue now that funding might be available.
